5. Co-Chair's Report

Co-Chair Hawekotte discussed the upcoming sunset date of the Nebraska Children's Commission on June 30, 2019 and the work around LR451. She highlighted that once a bill was introduced the group would need to monitor its progress and discuss the potential structure changes that may arise.

6. Update from Douglas County on Title II Funds

Douglas County representation was unable to attend the meeting. This update was postponed for a future meeting.

7. Legislative Discussion

a. Legislative Resolution Review

Chris Triebsch, Legislative Aide to Senator Patty Pansing Brooks, provided a brief overview of relevant legislation for the members. Highlighted items included work on legislation for juvenile right to counsel, a change in provision for the sealing of juvenile records, issues of solitary confinement, and addressing issues of disproportionate minority contact.

b. JDAI Update on Neb. Rev. Stat. §43-251.01

Monica Miles-Steffens was invited to provide an update on the work regarding Neb. Rev. Stat. §43-251.01. She explained that the Juvenile Detention to Alternatives Initiative (JDAI) Statewide Collaborative had formed a workgroup to specifically look at steps to prepare the communities for the upcoming legislation. A [handout of data](#) from the workgroup was provided to members. Members discussed the data at length, stressing the need for consistent definitions across systems along with community and home based services.

8. Office of Inspector General of Nebraska Child Welfare Report

The Co-Chairs welcomed Julie Rogers, Inspector General of Nebraska Child Welfare, to provide a presentation on the office's most recent annual report. She provided an overview of the work of the Office of Inspector General (OIG) and their most recent [annual report](#). Several topics inspired conversation including sexual abuse, licensing standards, and the rise in suicidal behavior. The groups talked at length regarding ways to create a model for crisis response for suicide prevention.

Members concluded that a future meeting should focus exclusively on the issue of suicide prevention for system involved youth. Areas to be addressed should include uniform statewide crisis response procedures, adequate preventative mental health services, and community education of prevention methods. The hope was to have a wide scope of participants that

would include county officials, law enforcement, hospital administration, rural community representation, 1184 team members, child death review team members, public health representation, university representation, and affected parents. The leadership of the JSC and NCJJ would meet to in the upcoming weeks to outline the structure of the event.

9. JSC Workgroup Updates

a. High Utilizers of Services Workgroup

Julie Smith, Co-Chair of the High Utilizers of Services Workgroup, described the focus of the group. Work had begun to examine and identify a clear and consistent high utilizer profile that could be used across systems. Smith noted the barriers of data sharing. She explained both the issues of confidentiality often prevent system partners from sharing information as well as the varying measures used by each system to identify their high utilizers. The hope of the group was to be able to identify if the correct services were in place to prevent youth from becoming more entrenched in the juvenile justice system, and if not, what services should be in place and at what point within the case progression.

b. Transition Services Workgroup

Workgroup Co-Chair, Kim Hawekotte, shared that the Transition Services Workgroup had been working to create both guidance checklists and procedures to assist in the transition of youth from various placements. The group planned to continue to delve into how best to support both educational and medical transition planning to ensure youth can achieve success when returning to their community.

c. Youth and Family Engagement Workgroup

Workgroup Chair, Vicky Thompson Smith, provided an update on the work of the Youth and Family Engagement workgroup. She spoke on the number of initiative and practices occurring throughout the state working to engage youth and family. The group hoped to gather a comprehensive matrix of current engagement initiatives and identify how best to support them and raise awareness. Through examining the various engagement initiatives, the group aimed to pull out the elements that allow for successful engagement along with any barriers preventing it.

10. NCJJ Subcommittee Updates

a. Executive Subcommittee

The Executive Subcommittee did not have any updates to provide at that time.

b. Community Planning Advisory Subcommittee

Elaine Menzel, Chair of the Community Planning Advisory Subcommittee, indicated that the group would be meeting the following day. The group had been working in conjunction with the Grant Review Subcommittee to look at definitions and framework for grant applications to help streamline the process. This group was also preparing to serve in the first round of reviews for Community Based Aid (CBA) fund applications.

c. Juvenile Diversion Subcommittee

An update of the Juvenile Diversion subcommittee was provided by group chair, Denise Kracl. The group had created a strategic plan for diversion in the state of Nebraska. From this effort three workgroups were formed: an advocacy workgroup to help spread education and awareness of diversion and its benefits, a data and assessment workgroup to help identify the population entering diversion and examine program funding, and a training workgroup to assist communities and stakeholders in learning how to best implement diversion practices.

It was requested that this subcommittee look at the potential financial barrier of diversion programs. Anecdotally, there had been the occasional reference to the cost of diversion being prohibitive for some youth and families. Kracl noted that training information would work to ensure communities knew that diversion programs should always work to be available to youth no matter their financial resources.

d. Grant Review Subcommittee

Elaine Menzel noted that this group is currently collaborating on several issues with the Community Planning Subcommittee.

11. Lunch

Members recessed for lunch from 12:10 – 12:30 p.m.

12. Office of Juvenile Services Update

Trevor Spiegel, Juvenile Services Administrator with the Department of Health and Human Services (DHHS), provided a [presentation on Moral Reconation Therapy \(MRT\)](#). He explained that every youth in the Youth Rehabilitation and Treatment Centers (YRTC) completed the program. He continued by discussing the shift to more normative educational format, improved vocational opportunities, and continued collaboration with the Department of Labor and Vocational Rehabilitation. Spiegel also briefly commented on the proposed fence for the YRTC, citing concerns for the youth safety within the community if they were to go missing from the campus.

13. Foster Care Review Office Annual Report Presentation

The Co-Chairs welcomed Dr. Katie Bass, Research Director with the Foster Care Review Office (FCRO), to review their most recent [annual report](#). Highlights included a shortage of treatment level placements, a high percentage of youth in probation based out-of-home placement that had previously been involved with the child welfare system, and the high number of cases in which parents are unwilling to allow system involved youth to return home. Bass noted that work was in progress to refine review questions to better address the needs of the youth involved in both child welfare and juvenile justice systems.

14. Probation Update

Jeanne Brandner, Deputy Probation Administrator for Juvenile Services, quickly noted a few items. Information shared included the upcoming retirement of the Probation Administrator, Ellen Brokofsky, a recent training initiative to refine case management and planning, and the work on in-home services. She also highlighted the struggle to identify sufficient providers of treatment services, particularly in the rural and western part of the state.

a. Crossover Collaboration Discussion

Jeanne gave the floor to Monica DeMent, an Administrator with DHHS, Division of Children and Family Services, and Amy Latshaw, Investigation and Evaluation Specialist with the Juvenile Services Division of the Office of Probation Administration. The two shared a [presentation](#) with members on the Crossover Youth Practice Model (CYPM). DeMent and Latshaw explained that they had been traveling across the state providing training on the initiative. They went on to describe the efforts to ensure collaboration between DHHS and Probation staff. The CYPM was intended to be a permanent practice with a continuous quality improvement process in place.

15. Public Comment

The Co-Chairs opened the floor for public comment. No public comment was given.

16. New Business

There was no new business.
