**V. Co-Chair Update**

Chair Monika Gross shared that the AR Special Report was submitted to the Legislature on December 7, 2023.

Amanda Adams thanked members for attending the Children's Commission retreat. Members who attended the retreat shared their thoughts and encouraged members to attend future retreats.

**VI. Strategic Planning**

Policy Analyst, Amanda Adams noted that in November the Children's Commission determined that moving forward the Commission will be looking at revising Strategic Priorities. Adams noted during agenda item IX that the Commission has assigned the AR Committee with looking at prevention services from other states

and what resources were available in Nebraska to reduce them. Members discussed adding this as a standing agenda item to discuss at each meeting.

## **VII. DHHS Update**

Jacie Boelts shared a presentation regarding AR and AR data. She highlighted changes such as a reduction in visits with families from three down to one due to feedback from families who noted the invasiveness of three visits. She also noted that AR will no longer require Protective Factors Questionnaire (PFQ) but that tool will remain available for use. Boelts noted that there is a process for case reviews that will indicate changes regarding outcomes.

Boelts continued by sharing information regarding Review Evaluate Decide (RED) Team. RED Team reviews any cases that do not meet any of the 16 exclusionary criteria. Boelts provided data from RED Team, such as intake numbers and outcomes of RED Team decisions: AR, TR, or Multiple Reporter.

Ivy Svoboda asked Boelts to provide the number and percentage of total intakes that end up going to AR.

Boelts shared that DHHS has added an NFOCUS button to indicate refused services. She provided specific data and answered questions regarding cases with subsequent intakes.

Boelts provided a list of services provided to AR families. Amanda Roth discussed the differences and creativity of the caseworkers in accessing certain services in rural communities versus Eastern Nebraska. Members discussed the availability of services in greater Nebraska.

Boelts continued, and shared the average length of cases statewide is 49 days for the last quarter – June-September.

Boelts concluded by explaining the new QA review process.

## **VIII. LB1173 NCC Response**

Amanda Adams spoke about the response to the 1173 Workgroup report. She noted that the largest conversation point was the prevention piece of the report. She noted that this committee has made many thoughtful recommendations that have been incorporated into the special report and 1173 Workgroup.

## **IX. Workgroup Updates**

Co-Chair Monika Gross welcomed the workgroup chairs to report out on the work of their workgroups.

### **a. Workforce Stability Workgroup**

Amanda Adams reminded the Committee regarding the previous work of the workgroup. One previous recommendation was to reach out to high school and colleges. Members discussed that perhaps DHHS can report out regarding their efforts but also find ways to impact private sector human services employees. Members agreed to have this as a standing agenda item to discuss.

### **b. Oversight Workgroup**

Co-Chair Carter noted that Workgroup met recently and discussed future recommendations, which could potentially include determining effectiveness of AR, DHHS review of cases who refuse services, monthly audits by DHHS of cases, and potentially reinstating reviews for cases upon subsequent intake, monitoring safety, and feedback from families with lived experience.

**c. Equitable Provision of Services Workgroup**

Adams noted that per conversation during this meeting the provision of services across the state is not equitable and this workgroup should start up again, but the group is lacking a chair. Adams encouraged the members to think of potential candidates from outside the committee to lead and join. Members discussed thoughts for moving forward in the absence of a group leader or regular meetings. Members agreed to have this as a standing agenda item at future meetings.

**d. Legal Resources Workgroup**

Chair Pat Carraher noted a recent meeting where the group discussed the availability of IV-E money or prepetition work. He noted a recent rule change that makes it easier to access the funds, but due to not having a centralized process for accessing the funds Nebraska may miss out. Carraher continued by noting pro-se petitions were discussed and declined by the courts. Carraher continued, by sharing the group is now focused on legal resources for navigating the educational system.
