### **Call to Order**

Karen Authier called the meeting to order at 9:03am and noted that the Open Meetings Act information was posted in the room as required by state law.

### **Introduction of New Members**

Legislative Bill 269 (LB269), signed by the Governor on June 4, 2013, added new members to the Commission. Kim Hawekotte, Executive Director of the Foster Care Review Office, joins the Commission as a voting member; Julie Rogers, Inspector General of Nebraska Child Welfare, as an exofficio member. Karen also noted that LB 269 changed the status of Kerry Winterer and Thomas Pristow from voting to ex officio members.

### **Approval of May 21, 2013, Minutes**

A motion was made by Mary Jo Pankoke to approve the minutes of the May 21, 2013, meeting. The motion was seconded by Pam Allen. Voting yes: Pam Allen, Karen Authier, Beth Baxter, Candy Kennedy-Goergen, Kim Hawekotte, Janteice Holston, Martin Klein, Norman Langemach, Jennifer Nelson, David Newell, John Northrop, Mary Jo Pankoke, Becky Sorensen, and Susan Staab. Voting no: none. Nancy Forney, Gene Klein, and Dale Shotkoski were absent. Motion carried.

### **Chairperson's Report**

Karen Authier provided the Commission with information on a Joint Commissions group that has been meeting to coordinate child welfare/juvenile justice reform efforts among the three entities. The leadership of the Nebraska Children's Commission, the Governor's Commission for the Protection of Children, and the Nebraska Supreme Court Commission on Children in the Courts has been meeting to share information regarding the focus and priorities of each entity. There was consensus that the group would meet on a quarterly basis to identify shared priorities and minimize potential duplication of efforts. The consensus of all three groups is that each group has its own focus but that there would be benefit from coordination of efforts. Karen indicated that she will keep Commission members updated on this group.

Karen noted that LB 269 provides for moving the office of the Nebraska Children's Commission from DHHS to the Foster Care Review Office and the move will be effective on July 1. Karen thanked Kerry Winterer and Thomas Pristow for the support from DHHS during the start-up phase of the Commission.

Karen highlighted changes made by LB216 which adds the Young Adult Voluntary Services and Support Advisory Committee to the Commission. This advisory group will make recommendations related to the implementation of supports and services for youth aging out of the foster care system. Karen noted that the creation of the advisory committee is listed on the agenda as an action item. LB 216 mandates that advisory committee members be appointed by July 1, 2013.

Karen reported that the Juvenile Services (OJS) committee has been moving forward with their strategic planning process and will give an update later in the agenda. Karen also reported on the community listening sessions that were being conducted by the Community Ownership Workgroup. Karen noted that the sessions provided some very useful insights and recommendations and noted that the Grand Island and Dakota County sessions would take place on June 19.

Karen also highlighted that Deb Daro would be presenting at 11:00am. She thanked the Nebraska Children and Families Foundation for arranging the private funding that made Deb Daro's visit to the Nebraska Children's Commission possible.

### **Legislative Update**

Senator Kathy Campbell provided a brief legislative update. Senator Campbell thanked Commission members for their support and for testifying at public hearings during the legislative session. Senator Campbell also recognized Liz Hruska for her work on fiscal notes and Michelle Chaffee for her work on the various bills related to children's issues.

Senator Campbell noted that it was a good legislative session and that a variety of senators introduced and assisted in passing legislation that will have positive impact on Nebraska children and families. Senator Campbell specifically highlighted:

- LB216 which provides supports and services for youth aging out of the foster care system.
- LB556 which provides better access to telehealth and provides a pilot for mental health services for children.
- LB269 which provides money for a policy analyst for the Nebraska Children's Commission.
- LB530 which implements the work of the Foster Care Rate Committee and extends the Nebraska Children's Commission through 2016.

Senator Campbell also noted that Senator Coash's bill on alternative response was held in committee to allow for some additional work to be done prior to the next session of the legislature. She also noted that there was a lot of work done with appropriations and that the Nebraska Children's Commission strategic plan was very helpful. Senator Campbell concluded her remarks by noting that all in all it was a very good session for kids.

### **Juvenile Services (OJS) Committee Report**

Ellen Brokofsky and Martin Klein provided an update on the Juvenile Services Committee, including a written report. The committee held a full day meeting on June 11 to work on the strategic recommendations of the Juvenile Services (OJS) Committee. Ellen and Marty noted that good progress was made on the strategic recommendations and that the committee would be working to incorporate the additional work assignments from LB561.

Marty also reported that the committee had three nominees for the vacancy created by a resignation. The committee has also identified candidates for the three new positions approved by the Commission. Marty noted that there were four nominees listed on the Juvenile Services (OJS) committee report that the committee is submitting for approval by the Commission. A motion was made by Susan Stabb to approve the committee membership nominations of Barbara Fitzgerald, Tina Marroquin, Mark Mason, and Dr. Ken Zoucha. The motion was seconded by Janteice Holston. Voting yes: Pam Allen, Karen Authier, Beth Baxter, Candy Kennedy-

Goergen, Kim Hawekotte, Janteice Holston, Martin Klein, Norman Langemach, Jennifer Nelson, David Newell, John Northrop, Mary Jo Pankoke, Becky Sorensen, and Susan Staab. Voting no: none. Nancy Forney, Gene Klein, and Dale Shotkoski were absent. Motion carried.

Ellen Brokofsky then provided information on LB561 and shared a summary, written by Corey Steel, which outlined the provisions of the bill. Ellen indicated that the committee will confer with the Community Ownership work group regarding availability of community based juvenile justice services.

### **New Business – Create Young Adult Voluntary Services and Support Advisory Committee**

Karen Authier reminded Commission members about the nomination request form that was e-mailed to Commission members on June 6, 2013, for the advisory committee. As noted in the e-mail, Karen asked Beth Baxter and Mary Jo Pankoke to assist her in putting together a slate of nominees from applications/nominations that were received.

A motion was made by Mary Jo Pankoke for the Commission to create the Young Adult Voluntary Services and Support Advisory Committee. The motion to create the committee was seconded by John Northrop. D., Senior Research Fellow at Chapin Hall, who has over twenty years of experience in evaluating child abuse treatment and prevention programs and who has directed some of the largest multi-site program evaluations completed in the field. Currently she is leading the development of the Doris Duke Fellowships for the Promotion of Child Well-Being. In a presentation entitled "Strengthening Community Prevention Services and Policy: The Collective Need for Change," Dr. Daro provided information on prevention services and policy and answered questions from Commission members.

## **The Young Adult Voluntary Services and Supports Advisory Committee: Guiding Questions for Workgroups (DRAFT)**

### **1. Eligibility and Transition from Current Service Array:** *to develop recommendations related to eligibility processes and transitioning from current to new programs*

- How will young people currently receiving former ward be transitioned into the Voluntary Services program?
  - How will the services and requirements change for these young people? When and how will they be notified of changes to the program?
- Who will determine whether young people are eligible for voluntary services and when?
- What services will be available to young people who are not eligible for Voluntary Services and how will young people be notified of these services?

### **2. Case Management and Supportive Services:** *to develop recommendations related to the design of case management and additional supportive services*

- Who will be responsible for providing case management for youth age 18 – 21?
  - Public or privately-contracted workers?
  - Will young adults who want to maintain their current worker have the opportunity to?
- Will case workers be dedicated to young adults or have a variety of ages on their caseload?
- What are critical elements of the practice model for case management of young adults? How will the case management approach reflect the unique developmental stage of emerging adulthood?
- How will workers be trained and equipped to address the needs of young adults?
  - Helping young people to successfully enter and complete postsecondary education?
  - Helping young people to find and retain employment?
  - Helping young people to find and maintain stable and safe housing?
  - Helping young people address physical and mental health needs?

### **3. Placement:** *to develop recommendations related to placement decisions and options.*

- How will placement decisions be made for young adults in the voluntary program?
  - How will young people's preferences be taken into consideration?
- What placement options will be part of the array of placements for older youth?
  - Will scattered site, supportive housing, or host homes be part of the service array?
- How will direct subsidies be administered to young people?
  - Will they be administered directly to young people and/or will they be administered through a third party who is responsible for ongoing support and contact with young person?
- What training is needed for kin, foster parents, and other caregivers regarding appropriate guidance and supervision of young adults?

- Are new or adapted policy/regulations needed for placement settings for youth aged 18 – 21?

**4. Case Oversight:** *to develop recommendations related to the review of cases of young adults, including policy and practices to support case oversight.*

- Who will be responsible for periodic reviews? Courts? Foster Care Review Board? Mediation Centers?
- How will reviews be structured to ensure young people are full partners in the process?
  - How can you ensure the venue is youth-friendly?
  - How will youth be prepared for meaningful participation?
- What training is needed for judges and others directed with oversight functions?
- Depending on the design of case oversight, will young adults need and be granted legal representation?

**5. Communication/Marketing:** *to develop recommendations related to communication and marketing strategies and materials to encourage and engage young adults in the program.*

- How will young people be made aware of new program requirements and benefits?
- What communication strategies are needed to effectively market this program to young people?
- What outreach activities are needed to reach young people who have left foster care (but are still eligible to return)?
- What communication materials and tool are needed?

**6. State Extended Guardianship Assistance Program:** *to develop recommendations related to the design creation of the extending guardianship program*

- What training is need for case workers and potential guardians to implement this program?
- What are the barriers to ensuring guardianships are eligible for federal subsidies and the strategies for addressing them and potential strategies for overcoming them?
  - What timeframe will it take to address barriers and begin claiming federal IV-E for guardianships?
- What funding streams can potentially be leveraged to expand the reach of the legislated funds for state extended guardianship?
- How will the state extended guardianship subsidies be allocated?
  - If subsidies are available to youth on a first come, first serve basis, will this be based on when guardianships are finalized or when young people reach age 19?

## Foster Care Reimbursement Rate Committee Nomination Form

The Nebraska Children's Commission is seeking nominations for the Foster Care Reimbursement Rate Committee. This committee will be working to review and make recommendations to the Nebraska Children's Commission in the following areas: foster care reimbursement rates, the statewide standardized level of care assessment, and adoption assistance payments. The committee will analyze consumer expenditure data reflecting the costs of caring for a child in Nebraska; identify and account for additional costs specific to children in foster care; and apply a geographic cost-of-living adjustment for Nebraska.

The Nebraska Children's Commission is seeking the following representatives:

1. Representatives from a child welfare agency that contracts directly with foster parents, from each of the service areas;
2. A representative from an advocacy organization which deals with legal and policy issues that include child welfare;
3. A representative from an advocacy organization, the singular focus of which is issues impacting children;
4. A representative from a foster and adoptive parent association;
5. A representative from a lead agency
6. A representative from a child advocacy organization that supports young adults who were in foster care as children;
7. A foster parent who contracts directly with the Department of Health and Human Services; and
8. A foster parent who contracts with a child welfare agency.

Members of the committee will be asked to serve for terms of four years and until their successors are appointed and qualified.
