Foster Parent Information

The purpose of this survey is to ensure that you are receiving the best possible service for foster youth and their families. This survey concentrates on the Nebraska Caregiver Responsibility (NCR) Tool. The NCR Tool is a document that is meant to be filled out to determine the level of care and responsibility that you, the foster parent, will provide to your foster child. The NCR is utilized for foster youth who are in the child welfare system. If you have a youth in your home who is involved in the juvenile justice system and placed with you through Probation, you will not have had an NCR completed for that youth.

You will not be asked to provide any identifying information about yourself, or your foster child. Answers collected from this survey will be provided in aggregate to the Foster Care Reimbursement Rate Committee to support the creation of recommendations to the Nebraska Children's Commission, Nebraska Department of Health and Human Services, and the Nebraska Legislature.
