3 Section 1. Section 43-4201, Reissue Revised Statutes of Nebraska, is
4 amended to read:

5 43-4201 (1) The Legislature finds and declares that:

6 (a) The Health and Human Services Committee of the Legislature
7 documented serious problems with the child welfare system in its 2011
8 report of the study that was conducted under Legislative Resolution 37,
9 One Hundred Second Legislature, First Session, 2011;

10 (b) Improving the safety and well-being of Nebraska's children and
11 families is a critical priority which must guide policy decisions in a
12 variety of areas;

13 (c) To improve the safety and well-being of children and families in
14 Nebraska, the legislative, judicial, and executive branches of government
15 must work together to ensure:

16 (i) The integration, coordination, and accessibility of all services
17 provided to children and families by the state, whether directly or
18 pursuant to contract;

19 (ii) Reasonable access to appropriate services statewide and
20 efficiency in service delivery; and

21 (iii) The availability of accurate and complete data as well as
22 ongoing data analysis to identify important trends and problems as they
23 arise; and

24 (d) As the primary state agency serving children and families, the
25 Department of Health and Human Services must exemplify leadership,
26 responsiveness, transparency, and efficiency and program managers within
27 the agency must strive cooperatively to ensure that their programs view

1 the needs of children and families comprehensively as a system rather
2 than individually in isolation, including pooling funding when possible
3 and appropriate.

4 (2) It is the intent of the Legislature in creating the Nebraska
5 Children's Commission to provide for the needs identified in subsection
6 (1) of this section, to provide strategic priorities for research or
7 policy development within a broad restructuring of the goals of the child
8 welfare system and juvenile justice system, and to provide a structure to
9 the commission that maintains the framework of the three branches of
10 government and their respective powers and duties.
