Change powers of co-personal representatives, co-trustees, co-guardians, and conservators, change provisions relating to accounts with POD designations, and authorize persons eighteen years of age to acquire or convey title to real property and to enter into and execute related legal documents

LB59 Cavanaugh

Change investigation and reporting provisions under the Children's Residential Facilities and Placing Licensure Act

LB60 Cavanaugh

Change terminology relating to shaken baby syndrome

LB154 Brewer

Authorize a study to improve reporting and investigation of missing Native American women and children

LB269 Friesen

Change provisions relating to ignition interlock permits and school permits

Provide for posting by public schools of a toll-free number set up to report child abuse or neglect
