5. Co-Chair Report

a. Legislative Discussion

Chris Jones, Policy Analyst for the Commission, was given an opportunity to discuss the passing of [LB600](#). The legislation included provisions to continue the Commission and its statutory committees in much the same format as they currently functioned. Members were encouraged to apply and share information on applying as members of the Commission.

The members also reviewed the list of [interim studies](#) focusing on [LR127](#) introduced by Senator Hunt. The group discussed how many of the items included in the LR were issues the SFA Committee had worked on or were still working on. It was agreed that outreach should be done to the Senator to see how the Committee may be of assistance.

Conversation landed on the issue of driver's license attainment for youth in care. Members discussed Senator Wishart's [LB219](#) and its status. Members revisited previous discussions of barriers to youth obtaining a driver's license which mostly landed on issues of insurance. After lengthy discussion, it was decided to delve deeper into the topic. It was suggested to pull together a panel of experts to discuss the potential of and barriers to easing access to driver's license for youth in care. The panel should include individuals familiar with insurance, the Department of Motor Vehicles, Opportunity Passport, and similar organizations.

6. Approval of SFA Committee Annual Report

Co-Chairs Helvey and Davis led members through the various sections of the report. Members discussed the need to broaden language for the Trafficking recommendation #3 to ensure that it was interpreted to mean any charge and not just sexual offences. Members also discussed the need to raise awareness of the youth and caregiver court forms.

It was moved by Payne Ackerman and seconded by Nathan Collier to approve the 2019 annual Strengthening Families Committee Report with alterations to the language of the third trafficking recommendation to clarify

the scope of charges and to allow leeway for grammatical or formatting corrections. There was no further discussion. Roll call vote as follows:
