5. Co-Chair's Report

Co-chair Hawekotte shared with the groups that appointments to the Juvenile Services Committee will need to go before the Nebraska Children's Commission, which has yet to be appointed by the Governor. Once the nomination of Bobbi Taylor is approved by the Commission it will then come back to JSC for a vote.

Children's Commission staff member Chris Jones shared a handout and updates on upcoming hearings regarding YRTCs; LR103 and LR200. Additionally, LR236, an interim study from Senator Lathrop examining issues related to juvenile justice has also been set for hearing. Following up on the list of legislative resolutions provided at the May 30, 2019 meeting, Jones shared that all have been referred to committee but have yet to be set for hearing at this time.

Chris Triebisch from the office of Senator Pansing-Brooks shared updates on LR208, which is tied to LB147, regarding physical contact and restraint of students. LR208 examines underlying issues arising from comment during debate last session to determine if agreement or consensus can be reached regarding best practice, that could be enacted into statute for these issues. Senator Pansing-Brooks is holding listening sessions with education stakeholders and the Education Committee to explore moving forward with a bill free of the issues originally raised during debate.

Co-chair Hawekotte shared an update on LR156, from Senator DeBoer, regarding juvenile suicide. Co-chair Hawekotte has reached out to Senator DeBoer to provide input and assistance from the JSC and NCJJ, and has yet to hear back. Hawekotte did not expect this resolution to be set for hearing at this late of date, but she will continue to monitor.

Regarding meetings of the Juvenile Services Committee and the Coalition for Juvenile Justice, it was brought forth by Hawekotte and agreed upon that joint meetings between the JSC and NCJJ will continue in the future.

6. Nebraska Crime Commission Update

Executive Director Don Arp shared updates on the Nebraska Crime Commission and the vision for the commission under his direction. He expects to have an open-door policy and to have as many voices in the room as possible to help inform what they do. He welcomes as much input and partnership to get to a shared outcome. He would like the Crime Commission to become a model for 21st century public safety. Director Arp announced a new division of the Crime Commission tentatively named the Juvenile Intervention and Programs Division. This division will serve as a comprehensive source for juvenile service related issues. Arp noted that Amy Hoffman has replaced Cynthia Kennedy in the role of Community Base Aid Director as well as Juvenile Diversion Director. Recent staffing changes have allowed Arp to examine the needs across the commission and make changes to fill those needs. Director Arp later added that by the end of the year 2020, all 93 counties in Nebraska will have a diversion program or will partner with neighboring counties.

On behalf of the Coalition for Juvenile Justice, Chairperson Blakely extended congratulations to Amy Hoffman on her new role with the Crime Commission.

7. Probation Update

Committee Member Kari Rumbaugh provided a handout sharing information about the juvenile justice system. Rumbaugh presented research provided by Annie E. Casey Foundation, Georgetown University, and Robert F. Kennedy Resource Center. Key points include investing resources on highest risk youth, a shift in language away from the term "offender," reducing case load size to accommodate the highest risk youth. Rumbaugh shared that the current probation population is around 55-65% high risk youth, while historically that number was around 30%. Data also suggests that specialization in juvenile justice is beneficial rather than viewing juvenile justice as a stepping stone to the adult justice system. Additionally, she shared that incentivizing and encouraging youth, and engaging and training parents both result in good outcomes. Skill building and Aggression Replacement Therapy that have recently been instituted in Nebraska have shown effectiveness. Rumbaugh also updated the committees regarding services gaps and the expansion of emergency foster homes in western Nebraska.

Rumbaugh answered questions regarding helping stakeholders understand the role of Probation, diversity of the committees, and data measurements.

Chair Blakely shared information about a brief recently released by National Training and Technical Assistance Center (NTTAC) on family involvement methodologies for juvenile justice involved families. NTTAC is an excellent resource.

Judge Gendler brought forth a suggestion for the committees to visit with youth in detention centers.

8. DHHS Update

Mark LaBouchardiere provided information to the committees regarding the recent removal of youth from the Geneva YRTC and transition to the Kearney YRTC. He shared information regarding the history of the physical structures of Geneva facility and the inspections that occurred in 2018 and 2019. LaBouchardiere also shared information about staffing levels at Geneva, the transition of the youth from Geneva to Kearney, and the DHHS response to this transition. LaBouchardiere answered questions regarding the transition timeframes, staffing, alternative location, visitation, long-term plan, and the outreach efforts to youth and parents of youth from Geneva prior to and during the transition.

9. Juvenile Services Workgroup Review

Julie Smith shared that the High Utilizers of Services Workgroup had created a smaller subgroup to examine data and reach out to data expert partners, and determined that a data project as such would be a larger project requiring time and funding beyond what is capable in a small group. Don Arp shared that the Crime Commission has a research contract with the university that may be of assistance to the High Utilizers of Services Workgroup.

Vicki Thompson-Smith shared that the Youth and Family Workgroup is situated in a good place to continue its work. The workgroup was most recently connecting with youth councils and committees to attend the workgroup meetings gather information from youth and collect best practices. The workgroup is in a good place to pick up in the same place where it last left off.

It was agreed that the Juvenile Services Workgroups will meet to determine whether they will continue in their current states or come up with new objectives for the following year. The workgroups will bring their recommendations to the following meeting in October.

10. Nebraska Coalition for Juvenile Justice Workgroup Review

Coalition Member Denise Kracl shared that, in conjunction with the goal of expanding diversion to all 93 counties in Nebraska, overcoming barriers, and spreading information about diversion, the workgroup has created a template handout in hopes of generating a grass-roots movement regarding diversion and its importance in good outcomes with involved youth.

Coalition Member Elaine Menzel shared that the Community Base Aide Committee is awaiting grant applications and looking at processes to reduce giveback to less than 15% or other avenues to re-grant the giveback money. Committee will also look at the length of grant applications and grant adjustments for flexibility of the grantees. The committee will meet and bring proposals for the Coalition to decide at the next meeting.

11. Suicide Prevention Conference Discussion

Co-Chair Hawekotte directed attention to a handout regarding UNL Center for Public Policy receiving a 5-year SAMHSA grant to study youth suicide prevention. UNL CPP reached out to the Juvenile Services Committee and the Coalition for Juvenile Justice to take the lead on suicide prevention and collaborate with the JSC and NCJJ.

After discussion regarding collaborative efforts between UNL CPP, JSC and NCJJ, **it was moved by Kari Rumbaugh from the JSC and Elaine Menzel from the NCJJ to create a joint subcommittee between JSC and NCJJ, starting with a gap analysis on suicide prevention and come out with best practices for a community plan. The motion was seconded by Nick Juliano from the JSC and Brian Halstead from the NCJJ.** There was no further discussion. Roll call vote as follows:
