GOAL OF THE NEW PROCESS

- STREAMLINE THE COMPREHENSIVE PLANNING PROCESS
- ASSIST COMMUNITIES WITH ACCESS TO RELIABLE DATA & EVIDENCE-BASED INTERVENTIONS
- ADDRESS SPECIFIC COMMUNITY NEEDS
- SIMPLIFY THE PLANNING AND APPLICATION PROCESS

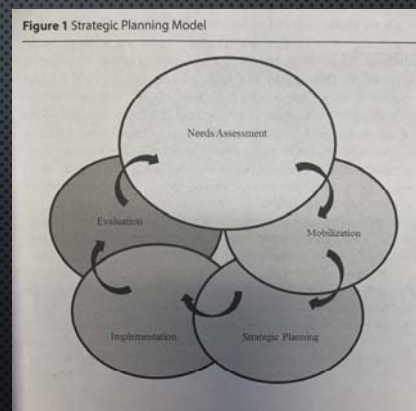


COMMUNITY NEEDS ASSESSMENTS

- PERCEPTIONS OF NEED COME FROM MANY SOURCES
 - THE NEWS, CULTURAL NORMS, ANECDOTAL STORIES... OR AN ANALYSIS OF COMMUNITY DATA!
- PURPOSE OF NEEDS ASSESSMENT:
 - USEFUL AND OBJECTIVE DATA
 - DISCOVER THE MAGNITUDE AND SERIOUSNESS OF PROBLEMS TO MAKE DATA-DRIVEN DECISIONS ABOUT SERVICE DELIVERY (WAMBEAM, 2016)
 - "NEED" IS A RELATIVE TERM; AS SUCH, IT IS RECOMMENDED THAT A GROUP OF STAKEHOLDERS WORK ON THE PROJECT (I.E., COMMUNITY LEADS AND TEAMS ARE INVOLVED)

STRATEGIC PLANNING

- Begins with a Needs Assessment
- Followed by mobilization of stakeholders and a data-driven strategic plan
- Implementation of services
- Evaluation!
- And then back again



SOCIAL ECOLOGICAL MODEL

- JJI FOLLOWED THE SOCIAL ECOLOGICAL MODEL (BRONFENBRENNER & MORRIS, 1998) – CHANGE OCCURS AT MULTIPLE LEVELS
 - INDIVIDUAL (YOUTH) MEASURES
 - RELATIONSHIP (FAMILY) MEASURES
 - COMMUNITY MEASURES
 - SOCIETAL (LAWS, POLICIES, PROCEDURES) MEASURES

COUNTY / TRIBES LEVEL NEEDS ASSESSMENT

THE **COUNTY NEEDS ASSESSMENT (CNA)** WILL BE PREPARED BY THE JJI. THE CNA IS AN ANALYSIS OF COMMUNITY NEEDS AS THEY RELATE TO JUVENILE JUSTICE , BUT COMMUNITIES MAY ADD OTHER DATA.

DATA POINTS INCLUDE:

- CENSUS DATA
- MEASURES OF CHILD WELFARE
- YOUTH REPORTED MEASURES (BOSR)
- NUMBER OF YOUTH AT EACH POINT IN THE SYSTEM
- RACIAL AND ETHNIC EQUITY
- LOCAL POLICY (APPOINTED COUNSELING & RECORD SEALING)

COUNTY LEVEL NEEDS ASSESSMENT

OTHER DATA NEEDS: IF COUNTY LEADS BELIEVED THAT ADDITIONAL DATA SHOULD BE INCLUDED IN THEIR NEEDS ASSESSMENT, THEY WORKED DIRECTLY WITH JJI TO ADD THOSE MEASURES.

THE CNA WILL ALSO INCLUDE INFORMATION ON STRENGTHS AND WEAKNESSES OF THE TEAM.

JJI IS SENDING CNAs OUT TO COMMUNITIES BY NOVEMBER 2020.

COMMUNITY TEAM



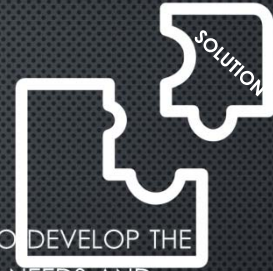
COMMUNITY LEADS WILL PREPARE TEAMS TO ANALYZE THE CNA BY INVITING TEAM MEMBERS TO TRAININGS. THE JJI WILL ASSIST WITH THE ANALYSIS THROUGH WEBINARS AND/OR REGIONAL MEETINGS.

TRAININGS WILL COVER:

1. UNDERSTANDING THE CNA DATA
2. ISOLATING THE COMMUNITY'S TOP NEEDS
3. IDENTIFYING RESEARCH-INFORMED INTERVENTIONS THAT BEST ADDRESS COMMUNITY NEEDS

COMMUNITY ANALYSIS AND RESPONSE

THE COMMUNITY WILL HOLD AS MANY MEETINGS AS REQUIRED TO DEVELOP THE **COMMUNITY ANALYSIS AND RESPONSE (CAR)** TO RESPOND TO NEEDS AND GAPS HIGHLIGHTED IN THE CNA.



NEEDS → INTERVENTION → FUNDING CONSIDERATIONS

THIS STEP OF THE PROCESS MUST BE COMPLETED BY **MARCH 1, 2021**. FORMS WILL BE AVAILABLE IN THE COMMUNITY PLANNING MANUAL.

DATA INTERVENTION MAPPING & IMPLEMENTATION SCIENCE

- RESPONSES TO COMMUNITY NEEDS SHOULD FIT WITH YOUR COMMUNITY' APPROACH AND LOCAL RESOURCES

JJI IS MEETING WITH EVERY COMMUNITY TEAM (45?!) ON INTERVENTION MAPPING AND IMPLEMENTATION SCIENCE

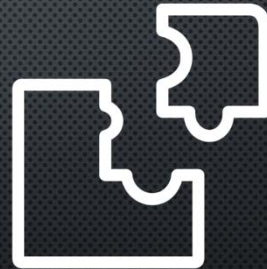


COMPREHENSIVE PLAN SUBMISSION

ONCE THE TEAM HAS COMPLETED AND AGREED UPON INTERVENTIONS THAT ADDRESS THE CNA, THEY WILL IDENTIFY GOALS AND OBJECTIVES FOR EACH INTERVENTION.

THE TEAM WILL CONSIDER:

- POTENTIAL RESPONSIBLE PARTIES
- A BUDGET



THESE ELEMENTS WILL LATER BECOME PART OF THE GRANT SUBMISSION. THE COMPREHENSIVE PLAN WILL BE DUE TO THE NEBRASKA CRIME COMMISSION BY **5:00 PM ON APRIL 2, 2021.**

COMMUNITY-BASED AID (CBA) GRANT APPLICATION

- **DUE APRIL 2, 2021**
- CONSISTS OF RELEVANT SECTIONS FROM THE COMMUNITY PLAN.
- EACH PROGRAM/SYSTEM IMPROVEMENT HAS ITS OWN SECTION, WHICH INCLUDES:
 - RELEVANT SECTIONS FROM THE CNA (IDENTICAL TO COMMUNITY PLAN)
 - RESPONSE TO THE IDENTIFIED NEED (IDENTICAL TO COMMUNITY PLAN)
 - GOALS & OBJECTIVES OUTLINED (IDENTICAL TO COMMUNITY PLAN)
 - RESPONSIBLE PARTIES
 - TIMELINE FOR EXPECTATIONS
 - BUDGET
