5. Co-Chair Report

a. Nebraska Children's Commission Update

Co-chair Vernon Davis welcomed members to the meeting and gave a brief synopsis of the meeting, noting that a majority of the meeting will focus on the pending annual report approval.

6. Legislative Update

Laura Opfer noted that the session resumes July 20th. Senator Pansing Brooks was on the Children's Commission meeting in May. Pansing Brooks noted that priorities are going to shift. Any bills with fiscal impact are at risk of not being prioritized. Opfer noted that LB 219, regarding Drivers Licenses and Foster Parent Liability has a small fiscal note

and is likely in jeopardy. Opfer added that that the Youth in Care Bill of Rights did not make it out of committee. Opfer will discuss this item later in the agenda.

7. Normalcy Subcommittee

Tom McBride updated the Committee on the recent activity of the Normalcy Subcommittee. He noted that they had a meeting recently and reviewed the Normalcy Reports, submitted by the providers. He added that there is a broad range of reports – some good and some not so good. Some reports also included agency responses to the COVID 19 situation. McBride questioned how the subcommittee can provide feedback to agencies. He noted that the subcommittee would like to incorporate feedback from the youth panel at each agency to get their feedback. McBride thanked Karen Moran for her work on collecting and distributing the Normalcy Reports. McBride proposed that the Normalcy Subcommittee have a meeting with those that wrote the reports to have a discussion about the writing process for the report and getting access for a discussion with the youth panel.

McBride continued by noting that the original intent of the legislation became watered down. He noted that simply writing the report and submitting it fulfills the requirement for the report. There is no consideration for the basis of the report. McBride thanked Laura Opfer for the input on the annual report. He has reviewed the recommendations of the report. Felicia Nelsen thanked the subcommittee members and added that after discussions with the agencies, the reports next year will be better than ever.

Laura added how important Normalcy is for youth, how far it has come over the years, and she thanked Tom and Felicia for their work.

It was moved by Vernon Davis and seconded by Jessica Rockemann to approve the Normalcy Subcommittee action plan of holding a feedback session with providers and those involved in writing Normalcy Reports, with a youth feedback session. There was no further discussion. Roll call vote as follows:

8. APPLA Subcommittee

9. Trafficking Subcommittee

Sarah Forrest shared via the chat function that the subcommittee on the recent work of the Subcommittee. She shared that at the most recent meeting the subcommittee there was a great presentation from DHHS on the most current data and policy progress made. The subcommittee identified many additional data needs and questions. She added that DHHS and Probation identified the need to work on services for this population. The subcommittee will reconvene in August/September to see if clear work plan and next steps emerge.

10. Annual Report

Laura Opfer shared that she has finished up work on the SFA annual report. She received feedback from a few members and incorporated those into the report. Opfer plans to add specific trafficking numbers on pages seven and eight of the report. She noted that this year has been a relatively slow year for the committee due to the pandemic, and reorganization.

11. Youth in Care Bill of Rights

Laura Opfer proposed forming a subcommittee to look at the Foster Care Bill of Rights. Felicia Nelsen proposed reconvening the Community and Family Voice Subcommittee to look at this Foster Care Bill of Rights. Sara Riffel noted that we could join the efforts in progress to add the support of the Committee and Children's Commission in the next legislative session. Opfer added that it would be important for the Committee and the Commission to be a part of the conversation. Riffel discussed the potential for helping remove the fiscal note that may be attached to the bill. Opfer shared that she will update the committee once a plan is in place.

Co-Chair Davis reminded those in attendance to reach out to the Governor regarding extending the relaxation of the Open Meetings Act, in order to continue meeting online during the pandemic.

Co-Chair Davis noted that the next steps for the Committee are to submit the annual report to the Children's Commission for a formal vote in August, and that each statutory group will bring their report to the Commission at that time.
