IV. Alternative Response Historical Overview

Laura Opfer welcomed Mikayla Wicks, Alternative Response Program Specialist, from Nebraska DHHS to provide a historical overview of Alternative Response. She shared a <u>PowerPoint</u> with information regarding the history and working order of Alternative Response. Wicks highlighted that AR is now a permanent program due to the passing of LB 1061, and she shared the process of AR intakes through case closure. She noted that AR links providers with families. She noted the 25 exclusionary criteria that exclude families from AR. Wicks compared Traditional Response (TR) and AR case paths. She shared the interview process, noting that in AR the parents are contact first via phone to begin building trust. Wicks continued by noting the randomizer is set to 90% of cases eligible being sent to AR. Regulations currently with the Attorney General would remove the filter. She shared the types of assessments completed and the forms completed with the family.

Wicks shared findings from the evaluation of AR completed by the University of Nebraska's Center for Children, Families, and the Law.

Wicks answered questions regarding Non-court cases vs. AR. She noted that some cases can go non-court after the end of AR or close. She also answered a question regarding payment, noting that cases can be referred in the normal process, and anything outside of that is purchased on the AR Purchase Card. Additionally, outside financial assistance services exist. Wicks explained the AR brochure and consent form and noted that she will share the form with members.

Members discussed 1184 team meetings, a multi-disciplinary team that meets to review intakes.

V. Nebraska Children's Commission Structure

Laura Opfer shared a Microsoft PowerPoint - AR Committee Overview 1.2021 (nebraska.gov) that provided a historical overview of the AR Committee and statutory requirements for the Committee. She noted the importance to continue focus on the requirements and the reporting timeline. Opfer also shared a graphic showing where the AR Committee fits within the Nebraska Children's Commission, and she note some important aspects of the Commission.

VI. Strategic Planning

Laura Opfer shared information regarding strategic planning, noting first steps of the Committee will be to fill the Co-Chair roles, survey the members to get an idea regarding the knowledge and any questions regarding AR, to determine the meeting frequency and topics, and develop subcommittees or workgroups.

VII. DHHS Update

Wicks reiterated some of the items from her PowerPoint, and asked the Committee what sort of items members would like to hear about in the DHHS Update portion of future meetings. She noted the downturn of cases due to COVID-19, and the gradual increase as communities reopen.

Members asked to see caseload sizes or information about dually-assigned caseloads and training statewide.

Laura Opfer welcomed public comment. There was no public comment.
