V. Strategic Planning Discussion

Laura Opfer shared a Power Point with information regarding the AR statute and the AR Strategic Planning themes. She discussed the themes and noted themes from AR, DHHS and Child Advocacy Centers. She discussed creating workgroups around the different themes.

- a. AR Statute Handout
- b. AR Summary Handout

Ivy Svoboda shared information regarding the themes from the Child Advocacy Centers. She noted themes regarding 1184 teams, oversight, and documentation of progress for non-court cases and criteria for case closure. Jennifer Carter added that the OIG is tasked with investigating critical incidents with AR cases, but short of that would recommend Multi-Disciplinary Teams look at cases. Mikayla Wicks added that there is a program specialist that also reviews the critical incidents. Wicks noted that specific data can be requested by CAC, County Attorneys, OIG, but the cases can't be discussed at 1184 team meetings.

Members discussed AR Participants rights and access to legal, service availability and equity across the state, and evaluating oversight mechanisms such as whether the 1184 teams are appropriate for oversight for AR as priorities for the Committee. Laura Opfer will bring drafted priorities for the next meeting to determine workgroup creation.

Co-Chair Thomas opened the floor to public comment. Nathan Arentsen provided public comment regarding the need for additional oversight and accountability of DHHS due to a traumatic personal experience involving an AR worker and his family.
