8. Nebraska Childrens Commission Strategic Priorities

Amanda Adams reviewed the Strategic Priorities from the Children's Commission.

9. YRTC Update

Proxy for Mark LaBouchardiere, John Baker shared that several weeks ago, YRTC Hastings held a law enforcement appreciation day. He noted that youth made goodie bags for the officers. He shared that there was one held in Kearney, where the facility had a barbeque.

Baker noted a spike of youth coming to YRTC from the Omaha area. He noted that some kids have been identified as gang affiliated and this has made for tense situations amongst the youth. He noted that of the 86 youth committed to YRTC. 43% from Douglas County. Central 8%, Eastern 44%, Northern 15%, Southeast 22%, Western 9%...

Dan Schleusener shared that his department expressed thanks for the recent law enforcement appreciation days held at the YRTCs.

10. Probation Update

Kari Rumbaugh distributed the annual report from Probation. She shared that it is also available online at https://supremecourt.nebraska.gov/sites/default/files/files/11854/Annual_Report_FY_2022_for_posting_on_website.pdf. Rumbaugh shared highlights from the report. She highlighted data from recent years. She noted that Probation population has recently risen, most likely after coming out of the pandemic. Rumbaugh also highlighted the incentive program and art contest.

Rumbaugh answered questions regarding out of home placements and probation revocations. Members discussed how probation modification orders affected this number.

11. Approval of the NCJJ Annual Report

NCJJ Chair Elaine Menzel noted that the report has been submitted to the Legislature, but not yet approved by the NCJJ. She noted the reason for the vote.

12. JSC Workgroup Updates

a. Access to Services

Julie Smith shared information regarding the recent meetings. She shared that the current focus is mapping the intersections of partners between, CFS, Probation, and Care Coordinators. She added that a current point of interest is evaluations.

b. Racial & Ethnic Disparities

Tami Soper shared information regarding the recent work of the workgroup. Amanda Adams noted that the workgroup has begun to look at funding for community based programs. Soper added that the workgroup is focusing on how to grow and provide technical assistance to smaller organizations that might need access to evidence-based evaluations and data. Soper hopes that the workgroup will bring together community partners in early 2024. Amanda Adams asked for assistance reaching out to community partners.

c. Youth Rehabilitation and Treatment

Nick Juliano shared a brief history regarding the workgroup and the process moving forward with a new plan and new name. Deb VanDyke-Ries noted that the intent is to expand the focus of the workgroup to look at the entire continuum of care, with the YRTC being the highest level. Members discussed how additional access to lower level placements may be beneficial. Julie Smith noted enough difference between this and the Access to Services workgroup. Through regular check-ins, the groups will work together. Jennifer Carter discussed the YRTC 5-year plan.

A motion was made by LaDonna Jone-Dunlap from the JSC to restart the YRTC Workgroup under the name Youth Justice Continuum of Care Workgroup. The motion was seconded by Vicky Smith from the JSC. There was no further discussion. Roll call vote as follows:

13. NCJJ Subcommittee Updates

a. Executive Subcommittee

NCJJ Chair Menzel shared that currently the Coalition is awaiting information from the Federal Government. Amy Hoffman noted that an application has been made and will likely need changes and workload in the future. Menzel will also be sending invites to the workgroups in the future.

b. Community Planning Advisory Subcommittee

Erin Wasserburger noted that the group will start again in January, noting that there was nothing on the agenda. Wasserburger noted that the group will be working on a process manual.

c. Juvenile Diversion Subcommittee

Amy Hoffman noted that there has been approximately 62 people trained in the NSAT. She noted no other updates.

d. Grant Review Subcommittee

Erin Wasserburger noted that the group has looked at juvenile service grants and plans moving forward. She noted that the CBA application has opened up recently and that they close December 20. Previous communities who have not applied recently have been reached.

e. Young Adult Subcommittee

Elaine Menzel shared that there are attempts to reinvigorate this subcommittee.

14. Community Based Aid Presentation

Devon Williams from Reconnect Inc. shared information regarding their program and Family Matters. She noted the program identified oppositional defiance disorder as a common thread among youth. She shared that Reconnect Inc. is able to work with youth on a personal level to build trust and family engagement. She highlighted success stories with the program. Williams is the author of "He or She Might have ADD." Williams shared that the CBA grant allowed the program to serve additional families. Williams noted that there is room to grow. She invited all the members to visit. Williams answered questions regarding caseloads and how the program interacts with individuals and families. She noted that the program utilizes evidence-based techniques but does not utilize a set curriculum. Members discussed availability in other counties.
