5. Policy Analyst and Legislative Update

Policy Analyst Chloe Fowler introduced herself and noted that she is coming up to speed on the work of the Commission and Committees under the Commission. She shared that she has been working on revising and drafting the reports and looking into what the Commission will focus on in the new year.

6. Approval of JSC & NCJJ 2025 Annual Report

The 2025 Annual Report was displayed for attendees. Members discussed revisions to the report at length.

Lauren Walag clarified that LB 530 passed, but the provision to lower the age for charging juveniles with serious felonies from 14 to 12 did not pass, and this revision must be made in the report.

Concerns were raised by Mark LaBouchardiere and Jennifer Carter regarding the difficulty in approving a document with substantive unreviewed revisions. Members agreed on a process to move forward. It was suggested to remove the Continuum of Care section from the immediate vote due to the magnitude of changes, allowing the rest of the report to move forward to the Children's Commission. It was also suggested that an ad hoc workgroup of the JSC convene to revise the Continuum of Care section prior to forwarding the report to the Children's Commission.

In response to a question, Adam Anderson explained that the scope expanded from solely juvenile justice R/ED to include child welfare and align with the Children's Commission's priority of equal service distribution. The name was changed to focus on driving services equally to all children and families across Nebraska in part due to pushback on targeted DEI

A motion was made by Dan Schleusener from the NCJJ to approve the NCJJ 2025 Annual Report with revisions to the membership lists and links to reports. The motion was seconded by Monika Gross from the NCJJ. There was no further discussion. Roll call vote as follows:

7. YRTC Update

Mark LaBouchardiere shared population counts at the Nebraska YRTC locations. He noted there are 19 youth at Hastings which will be going up to 23 soon, 103 at Kearney from 70 in April, and 14 at Lincoln from 10. He shared that these are significant increases at the facilities from April at a time when the facilities normally see decreases. He also shared that LB 530 could have population impacts at all the facilities. Lastly, he shared that the they have had their ACA accreditation and Hastings were compliant in 100% of all mandatory files and 99.4% of non-mandatory reviews. Lincoln was compliant in 100% of both mandatory and non-mandatory reviews. He congratulated both facilities for their work and noted a final panel review will happen in August for the official accreditation seal.

In response to questions, LaBouchardiere noted that the division is on track with the budget and the facility construction is still on track for completion in January 2026.

8. Probation Update

Amoreena Brady shared that Probation trained twenty-seven licensed providers across Nebraska in the TARGET (Trauma Affective Regulation: Guide for Education and Therapy) curriculum to address trauma exposure and its impact on youth functioning.

Brady updated the members that the Targeted Responsive Assessments for Court Key to Youth Success (TRACKS) screening and assessment process has been implemented across all probation districts except for District 5, which is scheduled to start on September 1st.

Quiroz expressed concern about rising costs, including the need to increase service provider rates, the potential for more youth in detention due to age expansion, the need for PRTFs, and potential impacts from changes to Medicaid.

Regarding the Juvenile Justice System Enhancement, Brady noted the recidivism rate dropped by two percentage points over the last quarter for youth in Restore services, even while serving higher-risk/gang-involved populations.

Quiroz shared that Probation is launching a new adolescent development curriculum, initially developed in District 3J (Lancaster County).

In response to a question about the "empty building sitting in Omaha," Sara Quiroz noted that the facility is a Douglas County issue and not overseen by Probation.

Quiroz shared that Brady has been recognized on a national level for her leadership during the launch of the JJSEN and noted that Probation is luck to have her and that she deserves the credit she received from the national recognition.

9. JSC Workgroup Updates

a. Access to Services

Adam Anderson noted that the workgroup is the most active workgroup working on the recommendations for the report and moving forward recommendations. He encouraged members to join the workgroup.

b. Racial & Ethnic Disparities

Chloe Fowler met with the chair about where the focus of the workgroup will land in the future. Adam Anderson encouraged members to join the workgroup.

c. Continuum of Care

Tammy Sassaman noted that she is trying to get new workgroup members as well as meeting in the future. Members added their names to the email list for future contacts.

10. NCJJ Subcommittee Updates

a. Executive Subcommittee

Elaine Menzel noted that the Subcommittee reviewed the agenda and worked on the public comment portion of the report.

b. Community Planning Advisory Subcommittee

Erin Wasserburger shared that the Subcommittee is in the process of scheduling a meeting to discuss community plans submitted for the CBA and JS grants.

c. Juvenile Diversion Subcommittee

Erin Wasserburger shared that they will be setting a meeting with new diversion program members. The group will be putting together a survey to reevaluate the Nebraska Screening and Assessment Tool. Wasserburger noted that the will be working with Drs. Hamilton and Compana for updates. The group has also released a best practice guidebook they are looking to get to county attorneys this fall.

d. Grant Review Subcommittee

Erin Wasserburger shared that the Subcommittee will be setting an August meeting to set the RFA process as well as set the priorities for the Enhancement and JS grants.

e. Young Adult Subcommittee

John Turner shared there is an August 5th meeting scheduled. He noted that they are in the process of rebuilding the Subcommittee.

11. Title II Update

a. Compliance and Monitoring

John Turner shared the JJDPA Compliance Report. He noted Nebraska is out of compliance with DSO (Deinstitutionalization of Status Offenders) requirements because nine status offenders were placed at Cedars, which is considered staff secure. Efforts are underway to find non-Title II grant funds to update the facility's door/locks, as Title II funds cannot be used for construction. He continued that the Greater Nebraska Youth Center of North Platte is also a staff-secure facility but is currently compliant, having hosted no status offenders in the last year. They are also actively seeking funds to immediately address their door security.

Turner noted that the state is in compliance with both the jail removal page and the requirement for Interests of Justice hearings for youth charged as adults.

b. Award and Budget Update

i. Prevention Grant

Erin Wasserburger noted that the prevention grant is awaiting a signature, before working on a contract for an online diversion program for rural areas. It would be a program good for low-risk youth. She noted that there will be a survey coming out.

ii. SFY26 Title II Award

Remaining funds contracted for R/ED and MST pilot looking at bachelor-level therapy at MidPlains, in rural areas. 2024 funding some but tribal passthrough changed. 2025 not release and will be 40% reduction based on compliance.

c. R/ED Plan Update

John Turner shared that Dr. Christian Bijoux will be assisting with R/ED Plan. Turner noted that the R/ED Subcommittee will be starting up again soon.

d. Partnership with Nebraska Children and Families Foundation - Lincoln Arneal

Erin Wasserburger noted that she will need to meet with Arneal to make sure that there is a plan in place for reimbursement for youth participation in the NCJJ.

e. Youth Summit
